**Subject: Critical Restricted Area Expansion with new NPSV Location**

On June 1<sup>st</sup>, 2018 at 10:00am, the Infield Terminal will become part of the Critical Restricted Area. This will include closing the existing Temporary NPSV on 5<sup>th</sup> Line Road and opening a new permanent Cargo West NPSV facility adjacent to Air Canada Cargo (Infield Cargo 1). During the first 6 weeks of operation for the new permanent Cargo West NPSV there will be a temporary canopy set up for vehicle screening. The permanent NPSV building will be operational and used for pedestrian screening. Please use the designated walkways with overhead protection to access the NPSV building.

Vehicles entering the Critical Restricted Area will be required to present themselves to NPSV for verification and screening as follows:

- All vehicles from Infield Tunnel Road will continue to be screened at the existing Temporary NPSV on Infield Tunnel Road.
- Licensed vehicles at the 3-Bay Hangar will be required to exit airside through a new egress point at PSL Gate V408C and then re-enter airside through PSL Gate 409 in order to be screened at the Infield Tunnel Road Temporary NPSV.
- Licensed vehicles at the CDF will be required to exit airside through their existing egress point and then re-enter airside through PSL Gate 409 in order to be screened at Infield Tunnel Road Temporary NPSV.

- Unlicensed/Authorized vehicles at 3-Bay Hangar/CDF will proceed to the new Cargo West NPSV via 5<sup>th</sup> Line Road.
- Vehicles from Infield Cargo 1, 2 and 3 will proceed to the new Cargo West NPSV.
