## Subject AMF and Administrative Building Parking Lot Repaving

The parking lots at the AMF building and Administrative Building will be repaved from October 2021 to December 2021. This work will be completed in a phased approach to minimize impact to AMF, Admin, and Air Canada employees. During this time, parking and access will be provided as per the following phasing plans. Figure with legend is located at the end of this document.

# Preparation Phase – Admin Main Lot, Admin Visitor Lot, AMF Lot, Admin Main Drive Lane

- Duration: From October 12, 2021 to October 19, 2021
- AMF employees:
  - Parking for AMF employees unaffected.
- Admin employees and visitors
  - Parking available for Admin employees in the main Admin lot. Parking spots near curbs will be unavailable. Follow temporary construction signage.
  - Visitor lot and main entrance drive lane will be unavailable.
  - Entrance and Deliveries to Admin building will be through Cafeteria Entrance only.
  - Main entrance will be closed.

# Phase 1 – Admin Main Lot

- Duration: From October 20, 2021 to November 15, 2021
- AMF employees:

- Parking for AMF employees unaffected.
- Admin employees and visitors
  - Parking available for Admin employees in the visitor lot only.
  - Entrance and deliveries to Admin building through Admin Main Entrance only.
  - Cafeteria entrance will be closed.
- Air Canada employees
  - Air Canada employees parking at the Training building and accessing the Annex building are to walk along Convair Dr to enter through the Annex east entrance only. Parking areas unaffected.
  - Annex west entrance will be closed.
- EV Chargers
  - GTAA employees may use the Cell Phone lot chargers. Alternatively, employees shall ensure that vehicles are charged prior to coming to site.

## Phase 2 – AMF Lot, Admin Visitor Lot, Admin Main Drive Lane

- Duration: From November 16, 2021 to December 20, 2021
- AMF employees
  - Parking will be available for AMF employees and Admin employees in the main Admin lot. Safe walking passage from Admin lot to AMF main entrance will be provided.
- Admin employees and visitors
  - Parking available in Admin main lot only.
  - $_{\odot}$   $\,$  Visitor lot and main entrance drive lane will be unavailable.
  - Entrance and Deliveries to Admin building will be through Cafeteria Entrance only.
  - Main entrance will be closed.
- Air Canada employees
  - Entrance to parking lot at Annex building will be reduced to one lane with traffic control for in/out traffic.
- EV Chargers
  - GTAA EV fleet vehicles will be available at the Admin charging stations only.
  - GTAA employees may use the Cell Phone lot chargers. Alternatively, employees shall ensure that vehicles are charged prior to coming to site.
