- Continue to monitor Directives and Advisories with content relative to the GOM 3.0 edition

**Background and Impact**: The Greater Toronto Airports Authority (GTAA) continues to pursue a strategy building a world-class airside operation, in terms of the safety and efficiency of the operation, at Toronto Pearson. The Ground Operations Manual (GOM) defines the objectives, policies, rules, and procedures that are designed to create a world-class operation. As such, the GOM is an essential reference for all airside operators, including airlines, ground service providers, tenants, and contractors. The purpose of this Directive is to announce the release of Version 3.0 and to highlight the major changes therein. These changes are summarized in Appendix "A".

The GOM has transitioned to SharePoint, making it more efficient to download and reference.
