Background: As previously communicated to the airport community and company designated signing authorities, the GTAA will introduce a fee schedule for AVOP testing and licensing effective January 1, 2022. These fees will be charged to the company signing authorities and billed through a chargeback process at the conclusion of each month. Invoicing details will be sent via email to the company with supporting documentation outlining any applicable charges and names of the applicants.

Written AVOP Testing Process:

To enhance the AVOP customer service experience as it relates to the written test process for AVOP, the GTAA will be establishing a booking process for all written exams for both D and DA licenses. Individuals wishing to schedule a written AVOP test can do so by using the online booking site at AVOP Test Booking, avop@gtaa.com or contacting the AVOP office directly at 416-776-AVOP (2867).

For any applicant who fails to show for a booked written exam or does not provide twenty-four (24) hours' notice of cancellation, a fee will be applied and sent to the applicant's company in line with the Fee Schedule above.

The written exam location and times for booking a test have not changed and will continued to be offered on Tuesday, Wednesday and Thursday, three (3) times per day at 0830, 1030 and 1330 in Terminal 1, adjacent to International Arrivals on the Arrivals Level – Room #FB1039, see appendix A for map.
