



Identification required for Canadian Citizens born in Canada


If your spouse or common-law partner is born in Canada, you will also require their birth certificate information.

Requirements for those with Extended Out-of- Country (OOC) implications

- Applicants who have been outside of Canada and the U.S. for more than 6 months, in the last five (5) years are required to provide supporting out of country (OOC) documentation, when applying for a Transportation Security Clearance (TSC) at the GTAA Pass/Permit Office.
- **Note:** This requirement does not apply to time spent outside of Canada and the U.S. before an applicant became a Permanent Resident or before an applicant turns 16.


