





- Number of callers has increased by 348%






January to April 2017 Complaints by Area



Runway Movements & Complaints January to April 2017




Runway Movements & Complaints January to April 2017 – Preferential Hours (00:00 – 06:29)

2017 Enforcement Investigations

Noise Abatement Procedures

- All arrival and departure operations are monitored for compliance with the Noise Abatement procedures using rules set in the Airport Noise and Operations System
- Listen to voice recordings between pilot and NAV CANADA for possible explanation ie.
 weather avoidance, safety

Night Flight Restriction Program

 All flights that operate during the Restricted Hours (12:30am-6:30am) are verified against night flight schedule and day of operations approvals

Formal Investigation

 When there is no evidence or reasonable explanation for non-compliance to the Night Flight Restriction Program or the Noise Abatement procedures, details are forwarded to Transport Canada for their investigation and potential enforcement action

Operational Trials Updates

North South Early Jet Turns

Certain small jet aircraft are permitted to turn to course shortly after takeoff on the east/west runways between 07:00 and 23:00.

- This is standard procedure since 2005.
- During the trial, early turns are also permitted on the north/south runways.

From March 3, 2008 to April 30, 2017

- 2, 777 eligible jet aircraft (17%) made early turns on the North/South runways
- 32 complaints are attributed to this trial.

Propeller Turns Extended Hours

Propeller aircraft are permitted to turn to course shortly after takeoff from any runway between the hours of 07:00 and 23:00.

- This is standard procedure since the 1970s.
- During the trial, prop turns are also permitted from 06:30 until 23:30.

From March 3, 2008 to April 30, 2017

- 3,968 props (91%) turned between 06:30 and 06:59
- 9,921 props (83%) turned between
 11:01 and 11:30 p.m.
- 311 complaints are attributed to this trial.
