Conditions for Hot Work Activities on Airport Lands

- 1. All Contractors carrying out hot work activities on Airport Lands <u>must</u> comply with the following Conditions and may use the CCPO Hot Work Sign-off Checklist included on the previous page or establish their own equivalent or better Hot Work Sign-off Checklist to track & document all their hot work activities.
- 2. The *<u>Contractor</u> working under a FAP assumes full responsibility for all hot work activities being carried under their scope of work and must review, understand, incorporate, and maintain all applicable mitigating fire safety measures as per Section 7.6 of the Airport Construction Code and as detailed in the Contractor's Project Specific Safety Plan (PSSP) which forms part of the conditions for the FAP that was issued.
- 3. A *<u>Competent Person</u> employed by the Contractor must review and assess each site where Hot Work will be carried out and then fully complete, sign & post the HWP Sign-off Checklist on site near the immediate location of the Hot Work activities.
- 4. Upon mobilization on site, the Competent Person may contact the GTAA Fire Prevention Office (416-776-4515) before any work begins to discuss potential fire hazards, general fire safety issues or concerns, expectations and the requirements for the Hot Work Permits being issued by the Contractor under the FAP.
- 5. Prior to commencing, the <u>Tradesperson</u> conducting Hot Work must have read, fully understand, and have checked that all the required precautions as detailed in the posted **Hot Work Sign-off Checklist** are in place and ensure that the Contractor's <u>Competent Person</u> has completed their review of the site & signed off that the area is safe to proceed with the work.
- 6. Digital copies of each completed **Hot Work Sign-off Checklist** must be emailed to <u>hotwork@gtaa.com</u> for potential follow-up/random site checks by CCPO or Fire Prevention.
- 7. Copies of all current & past completed **Hot Work Sign-off Checklists** must be kept on file for the duration of the project by the Contractor and must be produced when requested by the CCPO or their representatives.
- 8. <u>Failure</u> of the Contractor, their sub-contractor(s), or individual employee(s) to follow theestablished Hot Work Permit Process, or failure to implement, maintain and/or follow all fire safety precautions, will result in the <u>immediate stoppage of work</u> under the applicable FAP. Work will then not be allowed to commence until the contractor submits an incident report to CCPO detailing the noncompliance with the Hot Work Permit Process; and the corrective actions taken to remedy the noncompliance.

*Definitions:

<u>Contractor</u> – the organization who has taken responsibility for the Project through their submission of an NOP to the MOL, who has submitted a Project Specific Safety Plan (PSSP) to CCPO and to whom a FAP Placard has been issued to allow the commencement of the work under the project.

<u>**Competent Person**</u> – a person employed by the <u>**Contractor**</u> who is qualified by their knowledge, training, and experience to organize the work and its performance, is familiar with all applicable laws that apply to the work and has knowledge of any potential or actual danger to health and safety in the workplace.
